# Angela Bambrey: Front Royal’s Trailblazing Cricketer

## *USA team member will go to India for playoffs in November*

Angela Bambrey never imagined she would be doing anything like what she has recently encountered on her life’s path.

For one, growing up in the U.S.,

she never played cricket, a game she wasn’t familiar with. For another, as a person who has been blind for 26 years, she didn’t think she’d be able to play any sport.

But due to efforts by a group in India, there is now an organization called Cricket for the Blind, and she has been chosen to represent the US in the first Women’s T20 Cricket World Cup for the Blind

2025.

She is understandably thrilled. “In October the 29th we’ll go to India, fly into New Delhi then go on to Kathmandu in Nepal to play,” she said enthusiastically. “I got a passport but will need to get a visa! And I have realized that you’re never too old. I’m 43 and I can’t believe I’m part of a national sports team and I’m having a blast

with it!”

Their schedule will also take them to Bengalaru in India with six other countries participating in 21 matches - India, Pakistan, Nepal, USA, Australia and Sri Lanka.

“Some matches are a day long and some last for five days. We’re going to have a blast!” she added. “The women in our camps got along so well one of the coaches remarked that in India they’re so much more competitive.”

She and her husband, Cullen, have lived in Front Royal for many years, and raised their three children here, having moved from Charlottesville. “He was my high school sweetheart ‘the boy next door’ who lived down the block from my family, and we’ve been married for 21 years,” said Angela.

“My daughter Claire is 14, Lucy is 16, and our son Gregory is 19. My husband is a store manager in Manassas.”

They’ve raised their family here and Angela proudly spoke about their support and involvement.

Angela said that her daughter’s Varsity sidelines cheer group did a cheer to support her that she shared on Facebook on What’s Up Front Royal.

She also added some details about how blindness can be adapted for daily life.

“When you lose your sight, you

learn to use your other senses more, like hearing to know what’s going on. Now I know when the mail truck comes by because it makes a certain tone and vibration.

“I pay attention to my surroundings,” Angela continued, “I’ve taught my children to close their eyes and see if they can feel a curve in the road.

Her children have also been a part of keeping her in touch with the surrounding area.

“At Christmas, I ask them to tell me what’s nearby, and they describe things like Christmas lights and decorations for me.” She said they’re compassionate and sweet, giving Braille birthday and Christmas cards they made for her.

She has learned to read using the Braille alphabet (described as a tactile writing system that uses

raised dots to enable individuals who are blind or have low vision to read and write).

"Reading Braille is like reading a secret code and it's helpful with card games and books," she noted. "I just recently got The Princess Bride!"

She said that black noise and dark noise are used for echolocation, to make it possible for a blind person to navigate through their environment. This is described in the article, "Blindness no obstacle to those with sharp ears: NPR." Bats use echolocation, a biological sonar system, to navigate and hunt, like how man-made sonar systems operate.

When asked how she got involved with cricket she said she had discovered a group on a social media platform called Discord that facilitates social interaction and community building and allows users to engage in discussions, share content, and connect with others in real-time, like other social media platforms.

But its focus on voice and video communication, along with its server-based structure, sets it

apart from traditional social media networks featuring games, and allowing folks to text or do voice chat and talk to friends, useful for those with sight issues.

"It's awesome we can get together and talk and do exercises there as well," she said. "Technology is really nice because distance makes it hard, but we can spend time and motivate each other."

She found a friend there, Shannon Brett, who told her about blind cricket and offered to connect Angela with cricket manager Abigail (Abby) Finklea.

She did and this connection found her traveling to Long Island, New York to a short three-day camp and then Cupertino, California for a longer 10-day camp on August 12th.

"I found out I made the team!" she said and will head back to Cupertino on the 3rd of October for another camp.

"You never know what you can do until you try," she observed. "I wanted to try even if I didn't make it past the short camp and now, I'm so excited to go to India, I can't believe it. November 11th is our first game.

"I didn't know what cricket was but the people at the camp took all these women and showed us all the details," she said. "I absolutely love it! It's so nice to have a sport available for blind sports and this is the first time that I can get involved.

"I think the India trip is going to be amazing because there are players from 11 (US) states and also where we're going in such a short time," she said. "None of us have done this before and it's amazing that we can come together and do

this to be a team. We had mock games, but we didn't have 22 players, so we took turns filling in for the other side.

"Two of the coaches in the camp are from India and were blind

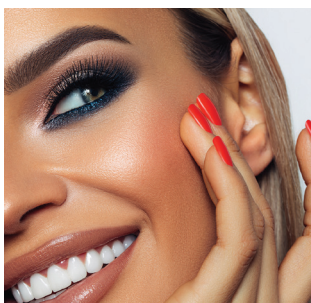
cricket players," she said. "They helped in practicing batting and field positions. We also took a fitness test and had a sports therapist who taught us warmups and Abby told me I'm a good all-around player—bowler, batter and fielder!

"When I came back from the camp my husband saw the bruises on my legs because I kept throwing myself on the ground!" she said. "When I go to get the ball on the

ground, that's my favorite part. When do you get to throw yourself on the ground other than when you're a toddler?

"I'm doing much better now with squats and lunges," she continued. "When batting, I lunge forward with my left leg and kneel with my right, then I can track while the ball is in the air because of the sound (modified balls are filled with ball bearings) then I sweep across the

ground.”

For practice, Cullen took her to a baseball field in town and made wickets. (a wicket refers to a set of three wooden stumps topped with two bails, serving as a target for bowlers)

For anyone wondering how the athletes play without vision, she explained that there are three levels of blindness, and while players in the B1 category are limited to batting, bowling or fielding, B2 and B3 players are allowed to run.

The classifications in blind cricket, based on their vision impairment levels are:

- B1: No light perception in either eye, but unable to recognize the shape of a hand at any distance or in any direction.
- B2: Ability to recognize the

shape of a hand up to and including visual acuity of 2/60 and/or visual field of 5 degrees or less.

- B3: Visual acuity above 2/60 up to and including visual acuity of 6/60 and/or visual field of more than 5 degrees up to and including 20 degrees.

These classifications determine the team composition and the rules for play, ensuring that blind and partially sighted players can participate in the game with equal opportunity.

Angela says that she belongs to B1, with her middle vision completely blanked out.

“The blindness I have is called Leber’s Hereditary Optic Neuropathy (LHON) where there’s no central vision,” she explained.

“When I was 17 it went into my left eye in March and then in May it went into my right eye. I could still drive after it went into my left eye but in May I was completely blind and couldn’t drive anymore. I didn’t know what would happen! But I have a good life, my husband is awesome, and I count my blessings.”

So since she is in the B1 category, she can’t run in the game.

“But I can hit the ball (using a ‘sweep shot’) and then B2 or B3 can run when I’m the bowler,” she noted, and added, “It’s good not to put B1 players next to each other so they don’t run into each other!”

Rules of blind cricket are based on the standard laws of cricket with some essential modifications.

Blind cricket relies on the common use of the ‘sweep shot’ on the ground in order to provide the maximum chance of the bat hitting the ball. The major adaptation of playing equipment is the ball, which is much larger than a standard cricket ball and filled with ball bearings to allow partially sighted players to see the ball and its contents allow blind players to hear it.

The wicket (stumps) is also larger, made of metal tubes painted in fluorescent colors, to allow partially sighted players to see and blind players to touch it in order to correctly orient themselves when batting or bowling. Various other modifications to the rules apply. Verbal signals are widely used both by umpires and players: in particular, the bowler must shout ‘Play!’ as

he releases the ball.

More information can be found on Blind cricket on wikipedia.org. Angela says she wants to explore getting a team in Virginia and from other US states and says, “The future would be amazing if teams from different states could play each other.”

Angela Bambrey’s selection to the USA Women’s Blind Cricket team marks a significant milestone for adaptive sports and local representation.

As she heads to India for the T20 World Cup, her story highlights the growing visibility of blind athletes and the role small-town communities like Front Royal play in supporting national talent.

## Mushrooms are the star of this meal



**Cream of Mushroom Soup**  
*Makes 8 servings*

- 7 tablespoons unsalted butter, divided
- 8 cups chopped mushrooms (about 1 1/4 pounds)
- 2 celery stalks, finely chopped (about 1 cup)
- 1 leek, white part only, thinly sliced (about 1 1/4 cups)
- 1/2 cup all-purpose flour
- 5 cups chicken broth
- 1 fresh thyme sprig
- 1 cup sliced mushrooms (about 2 1/2 ounces)
- 1 1/2 cups heavy cream, heated
- Fresh lemon juice, to taste
- Salt, to taste
- Freshly ground white pepper, to taste

Melt 6 tablespoons of the butter in a soup pot over medium heat. Add the chopped mushrooms, celery and leek. Cook, stirring frequently, until softened, 6 to 8 minutes.

Add the flour and cook, stirring constantly, 3 to 4 minutes.

Whisk in the broth gradually. Add the thyme sprig, bring to a simmer, and cook, 30 minutes.

Meanwhile, melt the remaining butter in a skillet. Add the sliced mushrooms and sauté until cooked through, about 5 minutes. Remove from the heat.

Remove the thyme and discard. Puree the soup, then strain through cheesecloth on a fine sieve. Return the soup to the soup pot and place over low heat. Add the heavy cream and season with the lemon juice, salt and pepper. Heat the soup, but do not let it boil.

Serve in heated bowls, garnished with the cooked, sliced mushrooms.

The weather is changing and soon it will be time to chase away chilly temperatures with hearty meals. Soup is a tasty way to warm up fast, and many soups are full of healthy and nutritious ingredients.

With their earthy, umami flavor, mushrooms sometimes are an afterthought instead of an ingredient to build meals around. But in the following recipe for "Cream of Mushroom Soup" from "The Culinary Institute of America Book of Soups" (Lebhar-Friedman Books) by The Culinary Institute of America, these humble fungi get to be the center of attention. Cremini, oyster and white mushrooms are equally at home in this recipe, or home cooks can experiment with a blend of mushrooms as they desire.

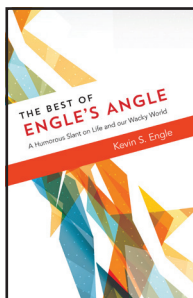

## ENGLE'S ANGLE: "From the Dark Ages to Blinded by the Light"

The following is a tale of light and darkness, good neighbors and a bad ballast. It is a true story.

"Let there be light!" my wife announced as she flipped the switch.

And there was. Too much.

"Oh my god," I cried out as I squinted, shielding my eyes from the solar flare emanating from our new kitchen lights.

It wasn't always like this.

Just last week, as I sat at the kitchen counter eating breakfast, a bowl of Cap'n Crunch® cereal, there was no light.

It was on, and then it was off. Just like that.

"What the?"

We were supposed to be headed out of town within the hour. My wife was

not happy. In fact, she was rather annoyed that we hadn't already changed out the light switch that had been behaving badly for months and decided she was going to take care of it right then and there.

After we finally figured out which

circuit breaker to shut off, she installed a new switch. She can do that stuff.

But when she turned it on, nothing. We'd deal with it in a few days when we got home.

Here's a question. How many times do you turn on a light switch out of

habit even though you know the light won't come on? A lot.

Putting new fluorescent bulbs in our kitchen light fixture is no easy task. It's an ordeal. One that requires a small step stool to get on the countertop and a six-foot ladder on the countertop to reach the fixture. A fixture that is approximately four feet long and twelve feet off the ground.

Because she has the skills, my wife always gets stuck with the job. With one hand, she holds the rectangular wooden frame of the four-bulb light fixture and with the other removes the screw that holds it in place. She then carefully spins each burned-out 48 inch fluorescent bulb just so to remove it. She hands it to me and I give her

a new one which she artfully installs, all the while still holding the wooden frame up with her other hand.

It's not easy to do.

But this time, new bulbs weren't the answer.

The ballast had died. You need a ballast whenever you have fluorescent lights. It's an electrical thing. If you want more details, ask an electrician or look it up. I did.

A wise and helpful neighbor who's been in this situation recommended we go another route.

LED bulbs. They don't require a ballast. They also last longer than fluorescent bulbs. My wife liked that

Ask Stewart

How often do trees get struck by lightning?

– Buzz

Quite often, because trees are the tallest features in the area and are the perfect conduit for electrical currents during thunderstorms. Some trees are more prone to being hit by lightning than others. Pines and oaks are more likely because their high resin and starch content make them highly conductive. Tall trees with deep roots are prime targets because the roots provide a clear path for the electricity to discharge into the earth.

When lightning strikes a tree, the 50,000 degrees Fahrenheit heat instantly boils the water within its cells, creating steam that can explode the tree's wood, causing bark to blow off, cracks to form, or even splitting the tree in half. The strike can also destroy the tree's internal water and nutrient-transporting vessels, leading to drought-like stress and eventual wilting or death.

The visible marks of a lightning strike are burnt parts, bark stripped off, long vertical scars and charred areas. After a lightning strike, immediate and continuous care is necessary for the affected tree. First, assess the tree's structure to make sure it is stable and safe. Then make sure the tree gets enough water to make up for the lost moisture. Watering with fertilization can speed up healing and new growth but major pruning should be done 2-6 months after the strike to let nature heal first. During this waiting period, only remove dead or broken branches without over-pruning the healthy parts of the tree.

If you have a valuable, vulnerable

or historic tree, a lightning protection system can be put in place. A typical setup consists of a rod, copper cabling and grounding equipment. The installation process involves burying a conductor wire in the soil which connects to an 8-foot deep grounding rod. When installed correctly, this setup diverts the energy from the tree to the ground below and reduces damage risks.

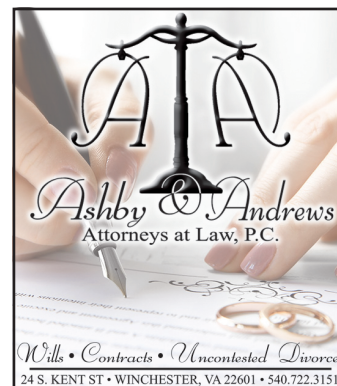

Warren County supervisor resigns Fork District seat

FRONT ROYAL, Va. — Warren County announced Wednesday that Fork District Supervisor Vicky L. Cook has resigned from the Board of Supervisors, effective Sept. 3, 2025, citing personal obligations.

“On behalf of the Board, we appreciate Ms. Cook’s contributions and her

commitment to the Fork District,” said Jerome Butler, chair of the Warren County Board of Supervisors. “County business continues without interruption. Our focus now is ensuring residents remain informed as we follow the legal process to fill this vacancy.”

County officials confirmed they have received Cook’s written resignation. The County Attorney is reviewing provisions of the Virginia Code to confirm the exact process and timeline for filling the seat. Once legal guidance is finalized, the county will announce whether an interim appointment will be made, along with details on how residents can participate.

Residents can expect a public update at the Sept. 9, 2025, work session. Additional information, including the process and timeline for filling the Fork District seat, will be shared through the county website, official social media channels, and at public meetings.

Continuous single-lane closures scheduled on I-81 northbound in Shenandoah County

STAUNTON — The Virginia Department of Transportation (VDOT) has announced a series of continuous single-lane closures on northbound Interstate 81 in Shenandoah County, scheduled for back-to-back weeks beginning Monday, September 8, 2025.

The closures will remain in place for up to 60 hours at a time to allow for critical rehabilitation of the concrete bridge deck over the North Fork Shenandoah River, just before exit 269 (Shenandoah Caverns/Mount Jackson).

Closure schedule  
Right lane closure: 8 p.m. Monday, September 8, through Wednesday night, September 10. During this period, the exit 269 off-ramp from north-

bound I-81 to Route 730 (Caverns Road) will also be closed.

Left lane closure: 8 p.m. Monday, September 15, through Wednesday night, September 17.

Exit 264 closure: During both lane closures, the exit 264 off-ramp from northbound I-81 to Route 211 at New Market will be closed to all traffic. Drivers heading to New Market should use exit 257 and follow Route 11 north for about six miles.

Depending on progress, weather and other factors, the closures may extend into early Thursday morning each week.

Restrictions and detours  
Vehicles wider than 12 feet will be prohibited from the work zone. Wide-load traffic will detour at exit 257 (Mauzy/Broadway/Timberville), follow Route 11 north for about 11 miles, then turn left on Route 730 to return to I-81 at exit 269. Virginia State Police will provide traffic control and enforce width restrictions.

Project background  
This work follows similar rehabilitation performed in May on the adjacent southbound I-81 bridge. VDOT officials explained that once the rehabilitation begins, it must proceed continuously to ensure quality and durability. The project is expected to extend the bridge’s service life and avoid more extensive and disruptive repairs in the future.

Both I-81 bridges over the North Fork Shenandoah River had received repeated temporary deck patching, which could no longer sustain heavy interstate traffic. Funding for permanent rehabilitation became available in spring 2025.

State police investigating fatal I-81 crash in Frederick County

FREDERICK COUNTY, Va. — Virginia State Police is investigating a fatal single-vehicle crash that occurred Saturday, Aug. 30, 2025, on Interstate 81 northbound at the 311-mile marker.

According to state police, a 2003 Toyota Camry was heading north when it attempted to pass another vehicle. The driver lost control and the Camry went off the left side of the road, crossed into the southbound lanes, rolled over and struck a sign.

The driver, identified as Ronald E. Paul Jr., 64, of Middletown, was transported to an area hospital, where he later died from his injuries. Police said Paul was not wearing a seatbelt.

The crash remains under investigation.

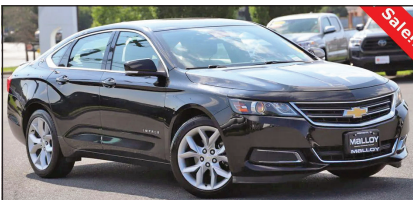
