COUNT ONE: In the County of Warren, Donovan Eugene Porter did unlawfully and feloniously, while having been the driver of a vehicle involved in which a person was injured, or an attended vehicle or other attended property was damaged, did unlawfully and feloniously fail to immediately stop as close to the scene of the accident as possible without obstructing traffic and fail to report the accused's name, address, driver's license number, and vehicle registration number forthwith to the State Police or local law-enforcement agency, the person struck and injured, or to the driver or some other occupant of the vehicle collided

with, or to the custodian of the other damaged property. The accident resulted in damage to property valued at \$1,000 or more. COUNT TWO: did unlawfully and feloniously steal a motor vehicle, having a value of one thousand dollars \$1,000 or more, belonging to Frank Barrett Jr. Dates of the offenses were on or about May 23, and August 25, 2025.

Circuit Court Grand Jury charges that: on or about April 29, 2025, in the County of Warren, Antoine Darnell Nicholson, 35, of the 700 block of Upsal St. SE, Washington DC 20032, did unlawfully and feloniously, having received a visible or audible signal from a law-enforcement officer to bring his motor vehicle to a stop, drive such motor vehicle in a willful or wanton disregard of such signal so as to interfere with or endanger the operation of the law-enforcement vehicle, or endanger a person, and

the speed of the accused exceeded the maximum allowed by twenty miles per hour.

A Grand Jury Indictment is only a charge and not evidence of guilt. The defendants are entitled to a fair trial with the burden on the government to prove guilt beyond a reasonable doubt.

Toffee Cheesecake Bars
Makes 2 1/2 dozen

- 1 cup all-purpose flour
- 3/4 cup confectioners' sugar
- 1/3 cup baking cocoa
- 1/2 cup cold butter
- 1 8-ounce package reduced-fat cream cheese
- 1 14-ounce can sweetened condensed milk
- 2 eggs, lightly beaten
- 1 teaspoon vanilla extract
- 1 1/4 cups milk chocolate English toffee bits, divided

1. In a small bowl, combine the flour, confectioners' sugar, cocoa, and baking soda. Cut in butter until mixture resembles coarse crumbs. Press in the bottom of an ungreased 13-inch x 9-inch baking dish. Bake at 350 F for 12 to 15 minutes or until set.

2. In a large bowl, beat cream cheese until fluffy. Add the milk, eggs and vanilla; beat until smooth. Stir in 3/4 cup toffee bits. Pour over crust. Bake 18 to 22 minutes longer or until center is almost set.

3. Cool on a wire rack for 15 minutes. Sprinkle with remaining toffee bits; cool completely. Cover and refrigerate for 8 hours overnight.

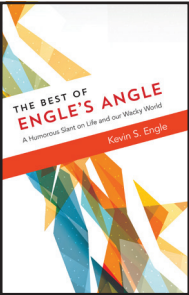

And because I don't tap it hard enough, that usually leads to several cracks and smacks before said egg actually escapes from its shell.

My current approach is to break each egg into a bowl, one at a time, so that I can fish out any little pieces of egg shells before pouring it into the skillet. Of course there's always raw egg running down the bowl and the side of the cup I use to break the eggs.

Once I finally do get all the eggs in the skillet, without any shells, I still have my challenges.

There are two essential skills in this phase of making eggs.

Scooping and flipping. I don't do either well.

We both like "dippy eggs" as my wife calls them. If I don't scoop them with the spatula just right, the dippy part comes out and won't be dippy anymore. I usually push the eggs around the skillet for a while until luck intervenes and I capture it.

But then it's time to flip.

Flip too hard and you break the yellow.

Flip not hard enough and I'm back to chasing eggs around the skillet again.

By the time I do flip the last egg, I've probably overcooked the first one.

An overcooked egg is not dippy.

I eat those.

Why should my wife have to suffer the consequences of my poor egg making skills?

The final step, getting the eggs out of the skillet and on to the plate can also be tricky. I can scoop, which is another opportunity to break the yellow, or I can slide them out. I'm so close to the finish line at this point. If I mess it up now, that really makes me mad. Cue the cursing.

What I need is a crash course in making eggs.

Virginia's role in meeting the needs of the world's growing use of artificial intelligence. He shared several key metrics illustrating how much the Commonwealth's energy landscape has changed, including a more than tenfold projected increase in the cost of generation capacity between early 2024 and summer of 2026, and the cop's 99 percent increase in the transmission service rate over the last decade. These rapidly rising power needs and the corresponding costs that challenge affordability for all Virginians require changing how the business of energy is conducted.

Hewa's philosophy at REC embraces the cooperative model, yet he recognizes "when the business changes, change the business." This is why REC leaders are effectively optimizing the capabilities of the cooperative model to manage risk and recognize opportunities.

"In Virginia, we need to accelerate regulatory reviews and permitting for new energy capacity generation. Additionally, we need to act today to prepare for operating during periods of scarcity by invoking energy storage and standby generation and authorizing emergency base load generation." Hewa called for the immediate emergency authorization of 10,000MW of baseload generation in the Virginia load zone.

Hewa also emphasized the need to consider all available options to address energy capacity generation, and to factor the wide variance in capital costs associated with different types of infrastructure investments. He concluded that for every \$10 billion in data center investment, Virginia needs \$3.5-\$10.5 billion in generation investment.

REC provides electric service to over 183,000 connections in parts of 22 Virginia counties. With its general office in Fredericksburg, Va., the Cooperative operates and maintains more than 18,000 miles of power lines through its service area, which ranges from the Blue Ridge Mountains to the tidal waters of the Chesapeake Bay. General Firearms Deer Season Starts Saturday - Set Yourself Up

For Success

RICHMOND, VA – Virginia's general firearms deer season begins Saturday, Nov. 15. Hunters hoping to fill their freezers are reminded to be safe, courteous, and have a detailed hunt plan. Planning for a successful hunt includes taking a hunter safety course and having a valid license. We hope all hunters enjoy a beautiful fall day afield!

Rewarding hunts involve conscientious preseason preparation, scouting, and good communications. This includes knowing the current hunting regulations. You should also inspect all gear including tree stands, safety harnesses, and firearms to ensure they are safe and operational. There are close to 250,000 acres of public land to hunt within DWR's Wildlife Management Areas. If hunting on private property, make sure you communicate with the landowner and have permission to hunt there.

Once that perfect morning arrives, there are a few more day-of things that will help make your hunt a success. First, make sure you communicate your plan with someone. Let them know where you plan to hunt and what time to expect you back home. Make sure to pack plenty of water, snacks, a first aid kit, and a cell phone or other means of communication. Check the weather, dress appropriately, and always wear the required blaze orange for safety. Know the property you plan to hunt including terrain and boundary lines and don't forget to bring a map or mapping app and a compass. If you're hunting from a tree stand, remember to wear a safety harness and use a fall arrest system. Finally, don't wait until you harvest that trophy buck to figure out a plan on how to get your deer out of the woods and processed.

If you plan to hunt in one of the chronic wasting disease (CWD) management areas, make sure you know the regulations including where carcasses can and can't be transported. Deer harvested on Nov. 15 in Patrick, Roanoke, Shenandoah, Smyth, Tazewell and Wythe counties are required to be tested for CWD. Staffed check stations will be open from 8 a.m. to 8 p.m. Staffed locations as well as refrigerated drop-off locations can be found on the CWD testing map. Deer harvested in other counties are not required to be submitted, but free testing is available to all hunters who wish to have a deer tested.

If your deer hunt includes the use of hounds, there are a few more items to check off on your hunt plan. Know the property you plan to hunt including terrain and boundary lines and ensure that you are casting and hunting on property where you have permission to do so. Make sure all your dogs wear a substantial collar with a tag displaying the owner's name and phone number. Make a plan to keep dogs on the property where you have permission to hunt. It is always a good idea to proactively reach out to landowners near the property you plan to hunt in case a hound becomes lost in the hunt. For additional best practices for hunters

that use hounds, visit the DWR webpage.

Once you fill your freezer this year, consider donating additional deer to Hunters for the Hungry. A list of participating deer processors can be found on their webpage. Deer populations on private lands in many areas of the state are higher than desired. Balancing herds through doe harvest keeps deer healthy, reduces property damage, and ensures healthy habitats for all wildlife. If you're in an Earn-A-Buck county, take another doe or two and help feed those in need.

Spending long days afield in the Commonwealth's wild places, sharing hunting stories with friends, and having a full freezer to feed their families is what makes fall the best time of year for many Virginians. If this includes you, DWR wishes you a safe and successful season! Warren Coalition Receives GDU Community Award

FRONT ROYAL, VA—In the midst of preparing for Celebrate Kids Day, Warren Coalition's Community Outreach Coordinator, Celeste Brooks, received some fun news: she and the Warren Coalition had been selected to receive the Global Day of Unplugging's "Community Award" in honor of their work on "Warren County Unplugged" this past March!

"In 2025, in Front Royal, you helped create something rare: space for people to step away from screens, look each other in the eye, and feel the power of real connection," the letter accom-

panying the award reads. "That's no small thing. This certificate isn't just paper. It's a testament to your part in a growing movement to reclaim our time, attention, and presence — and to the difference that simple, human moments can make."

With over 40 businesses, agencies, and nonprofit organizations participating in some way, the Coalition's second year of encouraging Warren County residents was considered a resounding success by Brooks and the rest of the committee. But they didn't expect national recognition for their efforts.

"We were just focused on creating the awareness," Brooks said. "And obviously the more organizations we have engaged, the greater the awareness."

This isn't the first time that the work of Brooks and the Coalition was noticed by the Global Day of Unplugging (GDU) staff. The GDU staff were so impressed with the social media work on the first event held in 2024, called "Warren County IRL (In Real Life)," that they named Warren County an honorary "Unplugged Village." That first event had mixed attendance at events, but signed up over 100 people to forego screens for at least a few hours during the 24-hour challenge, thanks to Brooks and Michael Whitlow of Over 50 Media. This year, the Coalition teamed up with Warren County Parks & Recreation and Warren County Public Schools to provide a stronger emphasis on youth, sending out educational materials through the schools and online, and organizing a "Youth Unplugged Party." It is estimated that over 800 people participated in events throughout the weekend, and nearly 250 signed up to "unplug" for at least a few hours.

Warren County Burn Ban

All open air burning throughout Front Royal/Warren County is pro-

hibited by order of the Fire Marshal effective November 6, 2025 at 11:00 AM. This order shall remain in effect until rescinded.

This action is being instituted in accordance with the Virginia Statewide Fire Prevention Code due to the extreme atmospheric conditions and dry ground/surface fuels impacting Front Royal / Warren County.. No person shall kindle or maintain or authorize to be kindled or maintained any open burning during this time. This prohibition includes all bonfires, ceremonial fires, camping fires, barrel fires, land clearing fires, etc. This regulation does not include barbecue grills, smokers, or any device that emits smoke through a chimney or stack.

The Department of Fire and Rescue Services, Office of Emergency Man-

agement and the County of Warren continue to monitor these adverse conditions. Violations of the Open-Air Burn Ban may be punishable as a class 1 misdemeanor, confinement in jail for not more than 12 months and/or a possible fine of not more than \$2,500.

Safety tips during this dry period to reduce the chances of fire include:





Do not discard cigarettes from moving vehicles; use ashtrays. With the conditions we have now, lit cigarettes do cause fires and can be disastrous in times of drought and high fire risk.




When pulling off the side of the road, stay off of dry grass areas. Park vehicles so that the exhaust does not come in contact with dry grass, leaves

or weeds.

Adjust the safety chains on your trailers to ensure they don't drag and create sparks that can cause roadside fires.

Avoid cooking outdoors during this drought season. If you do cook, never leave barbeque grills unattended. Place your grill on concrete or your driveway away from your home or any structures. If using charcoal or wood, make sure that the fire has been extinguished by soaking it with a garden hose before disposing of the coals.

Check lawnmowers and farm equipment for properly working spark arresters.

Mow your lawn at least 30-50 feet away from your house and water to create defensible space.

Cut back or remove any dry and dead landscaping plants or bushes around your home. Clear leaves from your roof and gutters; rake them away from the sides of your home.

Move anything that will burn far away from structures, items like firewood, compost piles, brush piles, etc.

Notify the electric company when dead trees or overhanging limbs endanger the electric wires.

Route 761 at Clarke-Frederick County Line Reopens after Bridge Replacement

STAUNTON – Route 761 (Old Charles Town Road) at the Clarke-Frederick county line reopened this afternoon (Wednesday, Nov. 5) following the replacement of the bridge over Opequon Creek.

Since early February, Route 761 had been closed to through traffic between the intersections of Route 666 (Gun Club Road) and Route 661 (Wadesville Road), requiring motorists to take detours around the construction.

The new bridge replaces one that was nearly a century old and had

reached the end of its service life. It was a low-water, single-lane structure that frequently flooded. The new bridge is roughly five feet higher and can carry two lanes of traffic. The new bridge will enhance safety and improve traffic flow on Route 761.

The Virginia Department of Transportation in November 2024 awarded a \$3.4 million construction contract to Fairfield-Echols, LLC of Fishersville. Although the new bridge is open to traffic, Route 761 motorists should be alert for shoulder closures or occasional flagger traffic control through the project's final completion in spring 2026.

All work is weather permitting.

Fatal Crash in Shenandoah County

Virginia State Police is investigating a two-vehicle crash that occurred at approximately 6:02 p.m. yesterday (Nov. 4, 2025) on Interstate 81

northbound at the 279-mile marker in Shenandoah County.

A 2024 Ford Explorer was traveling northbound in the left lane on Interstate 81 when it ran into a 2017 Freightliner tractor trailer that had stopped for traffic on the interstate. Traffic had stopped for a vehicle fire that occurred at the 283-mile marker. After impact, the Explorer spun across the right lane and ended up in the area between the interstate and the nearby on ramp.

The crash remains under investigation.

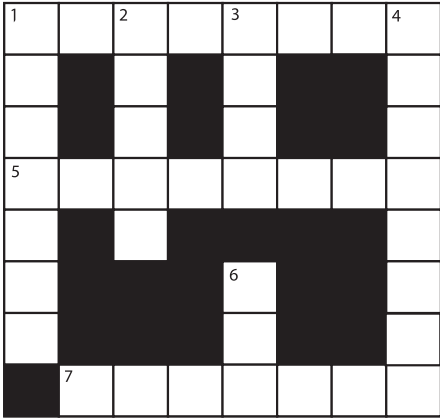
Double Fatal Crash on Interstate 95 in Spotsylvania County

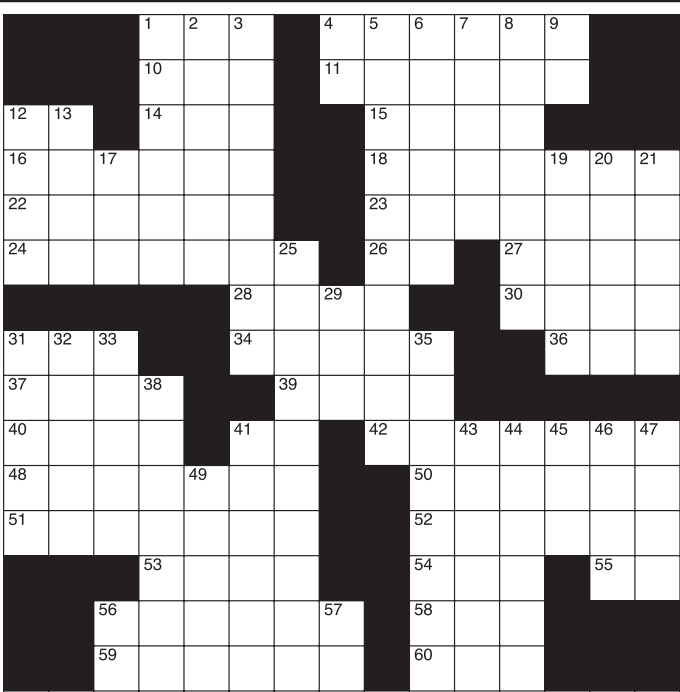

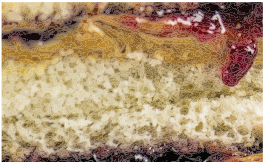

Frederick County Burn Ban in Effect

Due to the increased risk for wildfires due to the current extreme atmospheric and drought conditions, Frederick County will be under an open air burn ban effective Wednesday, November 5th until further notice.

No person shall kindle or maintain or authorize to be kindled or main-

tained any open burning during this time. This prohibition includes all bonfires, ceremonial fires, camping fires, barrel fires, etc. This regulation does not include barbecue grills, smokers, or any device that emits smoke through a chimney or stack.

This action is being instituted in accordance with Chapter 45 Article II section 45-10 E of the Frederick County code on the recommendation of Frederick County Fire Rescue System Fire Marshal and Fire Chief by the County Administrator.

The Frederick County Fire and Rescue System - Office of the Fire Marshal will continue to monitor these adverse conditions daily and make recommendations to the County Administrator and the Board of Supervisors on when to lift or amend the burn ban.

Violations and Penalty – Violations of the open burning regulations may result in being charged with and convicted of a Class 1 Misdemeanor, which carries a penalty of a fine up to \$2,500.00 and up to a year in jail. Further, if convicted, the responsible party may be held liable for all damages and the costs of firefighting operations.

Safety tips during this dry period to reduce the chances of fire include:

Do not discard cigarettes by throwing them down, use ashtrays or water to make sure they are out before disposing. Discarded cigarettes do cause

fires and can be disastrous in times of drought and high fire risk.

When pulling off the side of the road, stay off dry grass areas. Park vehicles so that the exhaust does not contact dry grass, leaves or weeds.

During this time, do not burn household trash in barrels.

If you cook outdoors, never leave barbecue grills or smokers unattended. Place your grill or smoker on concrete or your driveway away from combustible materials. If using charcoal or wood, make sure that the fire has been extinguished by soaking it with a garden hose before disposing of the coals.

Move anything that will burn far away from structures, items like firewood, compost piles, brush piles, etc.


